Brookville Road -- which abuts the parcel proposed to be vacated -- shall remain open and not be vacated. Any sale shall be upon the conditions that the parcel shall not be used in any manner so as to interfere with the use of Brookville Road by the public, or to endanger public safety in the use of Brookville Road, or to the material damage of the adjacent land owners.

As provided in Iowa Code Chapter 306.26, the funds received from any sale of the parcel shall be credited to the road fund of the Jefferson County Secondary Road Department.

WHEREAS, an integral part of the State of Iowa's Road Use Tax Fund (RUTF) is the fuel tax, which has not been significantly increased since 1989, while maintenance and construction costs have more than doubled during that same timeframe; and

WHEREAS, there have been several state-wide studies completed over the past 10 years identifying the requirement to significantly increase the amount of funding for the administration, maintenance and improvements to our state-wide public roadway system, including the 2006 Road Use Tax Fund (RUTF) study called for by Governor Culver, the 2011 Road Use Tax Fund (RUTF) study completed per 2011 Iowa Code Section 307.31, and the 2011 Governor's Transportation 2020 Citizen Advisory Commission (CAC) created by Governor Branstad; and

WHEREAS, the 2008 TIME-21 study documented the fact that under today's funding structure and highway usage, over 20% of the travel done in Iowa is by out-of-state drivers while only 13% of the state's road use revenues come from out of state drivers; and

WHEREAS, the funding provided by the implementation of the TIME-21 Fund in 2009 is inadequate to meet the critical maintenance and improvements needs for the State of Iowa's transportation system; and

WHEREAS, 95% of Road Use Tax Fund revenues are required by the Iowa Constitution to be spent only on our roadways; and

WHEREAS, due to the severe shortage in state funding to meet the critical needs of our roadway system, several Iowa counties have had to resort to issuing almost \$100 million in bonds to pay for their most critical maintenance needs, which will have to be paid off through property taxes; and

WHEREAS, Jefferson County has issued \$434,706 in bonds to pay for our most critical roadway and bridge needs; and

WHEREAS, the 2011 Governor's Transportation 2020 Citizen Advisory Council report to Governor Branstad and the Iowa Legislature identified the need for \$215 million per year of increased funding over the next 20 years, in addition to the funding being provided by the TIME-21 revenues, just to meet the most critical needs of our transportation infrastructure; and

WHEREAS, the Iowa Roads Association, the Iowa County Engineer's Association, and numerous business related associations throughout Iowa have publically supported the call for increased RUTF funding;

NOW THEREFORE BE IT RESOLVED that the Iowa State Association of County Supervisors and the Jefferson County Board of Supervisors strongly encourages the implementation of the 2011 Citizen's Advisory Council's recommendations to:

- 1. Increase the state fuel tax rates across the board by ten cents, over a period of no less than three years, resulting in an estimated \$184 million to \$230 million of additional annual revenue.
- 2. Increase the "Fee for New Registration" from five percent to six percent, raising this fee to a level consistent with the state sales tax, resulting in an estimated \$50 million of additional annual revenue.
- 3. Allocate new funding to go to the TIME-21 Fund up to the cap (\$225 million) and the remaining new funding should be distributed consistent with the Road Use Tax Fund distribution formula.

And, BE IT ALSO RESOLVED that the Iowa State Association of County Supervisors and the Jefferson County Board of Supervisors support the ongoing evaluation of creative, supplemental solutions to increased RUTF funding.

RESOLUTION FOR ESTABLISHMENT OF AREA SERVICE "C" ROADS

Jefferson County Resolution

WHEREAS, Jefferson County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance and access by means of a gate or barrier; and

WHEREAS, the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57; and

WHEREAS, the County has received a petition, attached to this resolution, signed by all landowners adjoining the road, requesting that the following road be classified as an Area Service "C" road; and

WHEREAS, the only persons who will have access rights to the roads shall be:

- (1) the owner, lessee, or person in lawful possession of any adjoining land,
- (2) the agent or employee of the owner, lessee or person in lawful possession of any adjoining land,
- (3) any peace officer,
- (4) any magistrate,
- (5) any public employee whose duty it is to supervise the use or perform maintenance of the road,
- (6) any agent or employee of any utility located upon the road.

WHEREAS, the minimal level of maintenance will be as follows:

- 1. <u>Blading</u>. Blading or dragging will not be performed on a regular basis.
- 2. <u>Snow and Ice Removal</u>. Snow and ice will not be removed, nor will the road surface be sanded or salted on a regular basis.
- 3. <u>Signing</u>. Except for load limit posting for bridges, signing shall not be continued or provided. <u>ALL AREA SERVICE LEVEL C ROADS SHALL</u> <u>BE IDENTIFIED WITH A SIGN AT ALL POINTS OF ACCESS TO WARN THE PUBLIC OF THE LOWER LEVEL OF MAINTENANCE.</u>
- 4. <u>Weeds, Brush and Trees</u>. Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained.
- 5. <u>Structures</u>. Bridges and culverts may not be maintained to carry legal loads. Upon failure or loss, the replacement structure will be appropriate for the traffic thereon.
- 6. <u>Road Surfacing</u>. There will be no surfacing materials applied to Area Service System C Roads on a regular basis.
- 7. Shoulders will not be maintained on a regular basis.
- 8. <u>Crown</u>. A crown will not be maintained on a regular basis.
- 9. Repairs. There will be no road repair on a regular basis.
- 10. <u>Uniform Width</u>. Uniform width for the traveled portion of the road will not be maintained.
- 11. <u>Inspections.</u> Regular inspections will not be conducted.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JEFFERSON COUNTY that this County does hereby establish the road described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

Description of road to be designated as an Area Service C Road:

Walnut Avenue, from the south side of 160th Street, extending approximately 2600 feet southerly along the Section Line between Sections 2 and 3 of T-72N, R-8W, thence extending approximately 1280 feet easterly, in Section 2 of T-72N, R-8W, to the end of the existing County right of way for this described portion of Walnut Avenue.

RESOLUTION TO VACATE A COUNTY ROAD AND CONVEY ROAD EASEMENTS TO THE STATE OF IOWA

Jefferson County Resolution No. 14-17

WHEREAS, A hearing was held on the proposed vacation and closure of a portion of Jefferson County Secondary Road, described as follows:

A segment of "Jefferson County Road No. 293," also named "Wright Road", originally established in September, 1870 (See Field Notes, Road Record Book 2, page 153), which is situated North of the Southerly boundary line of U.S. Route 34 and South of the Northerly boundary line of U.S. Route 34 (as U.S. Route 34 is currently located), said Road being formerly known as Ash Avenue, lying in Section 30, T72N, R11W of the Fifth Principal Meridian., Jefferson County, Iowa.

WHEREAS,

The intention of this action is to vacate the County's highway right-of-way interest in this segment of Jefferson County Secondary Public Road (original and with modifications), commencing at the Southerly boundary line of U.S. Route 34 and thence running in a Northerly direction to the Northerly boundary line of U.S. Route 34, causing no interference with the public's current highway usage of U.S. Route 34, the segment of road having been physically closed to traffic at the North and South termini. The land occupied by the above vacated road segment shall be subject to the right of a utility association, utility company, or utility corporation to continue in possession of a right-of-way in use at the time of this road vacation. It is intended that the County's highway interest in this portion of vacated roadway, which overlaps the existing U.S. Route 34 Highway boundaries, be absorbed by the State of Iowa.

WHEREAS, No objections have been received regarding the above described Road segment, either in writing or by persons present at said hearing.

NOW THEREFORE BE IT RESOLVED by the Jefferson County Board of Supervisors, acting under the authority of Iowa Code Chapter 306, that the subject section of closed County road, being held by easements as part of a County road right-of-way, be ordered vacated.

BE IT FURTHERMORE RESOLVED by the Jefferson County Board of Supervisors that the County's highway interest and easement for right-of-way, in the portion of vacated roadway which overlaps the existing U.S. Route 34 Highway boundaries, be transferred to and absorbed by the State of Iowa, the title holder and possessor of said Highway and of the roadway segment that is described below, together with all of our rights, interests, estates, claims and demands:

That portion of "Jefferson County Road No. 293," also named "Wright Road", originally established in September, 1870 (See Field Notes, Road Record Book 2, page 153), and also formerly known as Ash Avenue, which is situated within the boundaries of U.S. Route 34, lying in the Southeast Quarter of the Southwest Fractional Quarter and in the Southwest Quarter of the Southeast Quarter of Section 30, Township 72 North, Range 11 West of the Fifth Principal Meridian, Jefferson County, Iowa.

The last described portion being SUBJECT TO all other easements of record and the right of utility associations, utility companies, and utility corporations to continue in possession of a right-of-way for maintaining, repairing and replacing utilities in use at the time of this road vacation.
